

Declaration of Sovereignty  
July 5, 1999

A day late and 4 trillion dollars short, the time once again has come in the course of human events to rid ourselves from the evils perpetuated upon us from the greedy, self-righteous cowards of the Earth, that defy our rights bestowed upon us from our Creator, in order to usurp control over our lives and our society.
